

Arizona Cardinals® Charity Tailgate Contest

Official Rules

No Purchase or Text Message Necessary to Enter or Win.

1. Eligibility: The Arizona Cardinals® Charity Tailgate Contest (“Contest”) is open to local 501(c)(3) charities of Arizona. Employees, officers, directors, agents, and representatives of Arizona Cardinals, LLC, the National Football League, its member professional football clubs, NFL Ventures, L.P., Phillips Law Group (“Sponsor”), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising & promotion agencies (hereafter collectively, the “Released Parties”), and each such individual’s immediate family members (mother, father, sister, brother, child, husband, wife, and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are not eligible to participate or win. Void outside Arizona, and where prohibited by law. All applicable federal, state, and local laws apply.

2. Promotion Period: Nominations and voting begin at 10:00:00 AM Mountain Time (“MT”) on 10/21/2019. The nomination period ends at 11:59:59 PM MT on 11/03/19. The voting period ends at 06:00:00 AM MT on 11/20/2019 (“Promotion Period”).

3. How to Nominate/Vote for a Charity: During the Promotion Period, nominate and/or vote for a charity by:

- 1.) Online: Visit <https://phillipslaw.cjid.co> and follow the instructions provided to complete and submit the registration form to receive one (1) entry.

Nominations must be received by 11:59:59 PM MT on 11/03/2019 to be eligible. Votes must be received by 06:00:00 AM MT on 11/20/2019 to be eligible. For the purposes of this Contest, a day is understood to begin at 12:00:00 AM MT and end at 11:59:59 PM MT the same day. Limit one (1) entry per charity. Released Parties are not responsible for incomplete, late, garbled, lost, illegible, delayed, misdirected, or stolen entries, purchases, or text messages, failures or malfunctions of phones (including wireless phones/handsets), phone lines, cellular equipment towers, telephone systems, lost nominations or votes, text messages, or transmissions, interrupted or unavailable network, server, wireless service provider, or other connections, miscommunications, failed computer hardware or software or technical failures, garbled, misrouted, scrambled transmissions, printing, typographical, or other errors in these Official Rules, in any Contest-related advertisements, or other materials, or other errors or problems of any kind whether computer, network, cellular, human, electronic, or otherwise relating to or in connection with this Contest, including, without limitation, any errors or problems which may occur in connection with the administration of the Contest, the processing of entries or text messages, or in the announcement of the prize. The use of automated or similar devices, including but not limited to entries submitted using any bot, macro, script, or contest service (or any other devices intended to automate any aspect of entry) to enter this Contest is prohibited and any entries made through such means are void. Mechanically reproduced entries are void. Released Parties are not responsible for any injury or damage to the entrant’s or any other person’s wireless phone/handset/computer/device related to or resulting from participation in this Contest. Entrants to the Contest will be given the option to receive commercial e-mails from Arizona Cardinals and/or Phillips Law Group; however, eligibility to participate in the Contest is not dependent upon entrant’s consent to receive such e-mails and consenting to receive such e-mails does not impact the nominated party’s chances of winning. By entering this Contest, charities give their express permission to be contacted by Sponsor by telephone and/or e-mail for Contest purposes.

4. Winner Selection/Odds: Grand Prize charity will be selected by the most eligible votes from community members on/about 11/21/2019 from amongst all eligible votes received by Sponsor. Odds of winning depend on the number of votes received. The potential winning charity will be notified by e-mail and/or telephone number. In the event of a dispute as to the identity of any winner, the winner will be deemed as follows: Online: Winner

will be deemed the charity named on the applicable nomination form. Proof (to Sponsor's satisfaction) of being the primary Charity Director may be required by Sponsor. The Released Parties are not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in charity's e-mail accounts to receive e-mail messages. The Released Parties are not responsible for false, incorrect, changed, incomplete or illegible contact information.

5. One (1) Grand Prize: The Grand Prize charity will receive a Charity Tailgate Party consisting of the following: i) a tailgate party to take place before the Arizona Cardinals® game on 12/01/2019 in Phoenix, Arizona and tickets to the game for up to 180 people ii) \$2,500 cash donation. Exact seat locations to be determined solely by Sponsor. Tickets are subject to terms and conditions specified thereon. Charity and guests agree to comply with such terms and conditions as well as agree not to act in an unsportsmanlike or disruptive manner, or with any intent to annoy, abuse, threaten or harass any other person at the venue. Charity and/or guests can be escorted out of venue by designated agent(s) for improper conduct and/or violation of federal, state, or local laws (including, but not limited to, the unlawful possession, use, or distribution of illicit drugs, unlawful drug paraphernalia, and alcohol), as venue management determines in its sole discretion, and winner will forfeit the balance of his/her prize. Other than the details of the Grand Prize outlined above, Released Parties have no additional obligations or commitments to the Grand Prize charity in connection with this Contest. All prize details are at Sponsor's sole discretion.

6. Miscellaneous: No transfer, assignment, cash redemption, or substitution of prize (or portion thereof) except by Sponsor, who reserves the right to substitute a prize(s) with one of comparable or greater value (except as otherwise provided above), at its sole discretion. Grand Prize charity will be required to execute and return an Affidavit of Eligibility, Liability Release, and (where legal) Publicity Release and any other documents required by Sponsor within five (5) days of date of notification. Non-compliance with the foregoing, with these Official Rules, or return of prize notification as non-deliverable may result in disqualification and, at Sponsor's discretion and time permitting, awarding of prize to an alternate winner. Charities agree, by entering, that 1) Sponsor and its designees may use (unless prohibited by law), charity's name, city and state of residence, photograph, any recording (voice, film, or video), and/or likeness for advertising, trade, and/or any other purposes in any media now or hereafter known throughout the world in perpetuity, without further compensation, permission, or notification; 2) Sponsor reserves the right to conduct a background check and entry in the Contest constitutes charity's permission for Sponsor to conduct such background check, provided that, to the extent additional authorization is necessary under law, charities shall authorize such check. Sponsor reserves the right (at its sole discretion) to disqualify any charity based on the results of the background check or failure of the charity to properly authorize such check; and 3) the Released Parties shall have no liability and will be held harmless by charity or its guests for any claim, action, liability, loss, injury, or damage to charity or any other person or entity, including, without limitation, personal injury or death to charity personnel, guests, or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use, or misuse of the prize and any travel or travel-related activity thereto (including, but not limited to, attendance at the game) or participation in this Contest. Sponsor reserves the right, in its sole discretion, to modify, suspend, and/or terminate this Contest (or portion thereof) for any reason, including should virus, bugs, non-authorized human intervention, or other causes corrupt or impair the administration, security, fairness, or proper play of the Contest and, in the case of termination, at its discretion, select the winner from eligible non-suspect entries received prior to the event that required such termination. **CAUTION:** Any attempt to deliberately damage the website or undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made; the Sponsor reserves the right to seek any and all remedies available from any such person(s) responsible for the attempt to the fullest extent permitted by law.

and exclusively by final and binding arbitration under the rules of the American Arbitration Association (“AAA”) and held at the AAA regional office nearest the charity; 2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and 3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will charity be permitted to obtain awards for, and charity hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than charity's actual out-of-pocket expenses (e.g., costs associated with participating in this Contest), and charity further waives all rights to have damages multiplied or increased.

8. Choice of Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of charity and Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the substantive laws of the State of Arizona, USA.
